



Flushing CSA Membership Agreement 2023 Spring-Summer Season

By signing below, I commit to membership in **Flushing Community Supported Agriculture (CSA)** for the 2023 harvest season (June - November, 22 weeks). I understand that this is a community project and I, or my representative, will **volunteer a minimum of six (6) hours** during the season to help the Flushing CSA. I understand that share distribution occurs on a weekly basis and that I am responsible for **picking up my share at the Friends Meeting House (across the street from Flushing Town Hall) at 137-16 Northern Blvd, Flushing 11354. Distribution will be on Wednesdays from 6:00 - 8:00 pm. Shares not picked up by 8:00 p.m. will be forfeited.** Please note the pickup will be outside on the porch. The shares will be individually bagged and named. The volunteers will check off your name. A face mask and social distancing are required. This is all being done for COVID safety purposes. I understand at the core of CSA is the idea that members support their farmer by sharing in the inherent risks of agriculture (poor weather, drought, disease, early frost, crop failure and so on) and rewards (the bounty from a good season!) Therefore while Norwich Meadows Farm will act in good faith to provide fresh organic produce for the 22-week season, **there is no guarantee of quantities or contents of weekly shares.** I understand that it is my responsibility to stay informed of CSA announcements through email or notices at the distribution site.

Shares are ordered with Flushing CSA using this form. Egg and fruit add-ons are only available with a regular share. There is also an administrative fee of \$15 is due to Flushing CSA. Both the share payment and administrative fee can be payable by Zelle (flushingcsa@gmail.com) or check to Flushing CSA.

After February 9th until March 15th:

- Regular Share: \$738.00
- Large Share: \$1388.00 (\$63.64 per week)

- 1 dozen bi-weekly (11 weeks): \$82.50
- 1 dozen weekly (22 weeks): \$165.00

- Bi-weekly (10 weeks) - \$170.00
- Weekly (20 weeks) - \$340.00
